## **Attracting New Investment for Communities**



Gillian McLees (Panel Facilitator) Director for BtR, Rettie & Co.& Scottish Chair of ARL (Association of Rental Living)

Gillian is currently working at the forefront of providing operational support across all aspects of Built to Rent in Scotland & The North, including managing BTR across all tenures. She sits on the SPF Investment and management committee and is the current chair of the UKAA Scottish hub. She has worked with the Scottish Government providing research on PBSA and has consulted on all rent controls and BTR frameworks.

She started working in PBSA as an Accommodation Manager in 2012 in what was one of the first large operational buildings in Scotland. #### **Craig McLaren** National Planning Improvement Champion

Craig McLaren is Scotland's first National Planning Improvement Champion. This role was established in the 2019 Planning Act to develop a new framework that monitors planning performance and supports improvement; to identify, share and apply good practice; and to establish strategic challenges and broker action. Craig is based in the Improvement Service and took up post in September 2023.

Prior to that he was Director of Scotland, Ireland and English Regions in the Royal Town Planning Institute; Director of the Scottish Centre for Regeneration in Communities Scotland/ Scottish Government; Chief Executive of SURF (Scottish Urban Regeneration Forum); Scottish Policy Officer at RTPI; and a planner in the London Borough of Kingston upon Thames.

Craig is a Fellow of both the RTPI and the RSA, and an Academician of the Academy of Urbanism. He has sat on the Boards of Scotland's Towns Partnership, Built Environment Forum Scotland, Greenspace Scotland, Resilient Scotland and the Jim Boyack Memorial Trust.

His spare time revolves around family, football and music. He tries to attend a gig a month, plays the drums and can strum a guitar badly.















#### **Sarah Shaw Head of Planning** Glasgow City Council

Born in Glasgow, went to school and University in Dublin, where she did a law degree at Trinity College before returning to her roots in Glasgow to do a Masters in Planning at Strathclyde University. After a brief period in the Lake District she started at Glasgow District Council in forward planning. Subsequently in 1996 she moved to development management (planning applications) moving into management, and now Head of Planning for Glasgow City Council from 2021. She is a part of the Heads of Planning Scotland Executive Committee.

Danny is a Chartered Landscape Architect and Geographer with 30 years experience leading regeneration, economic development, and infrastructure projects across Scotland. ## **Revitalising Our Towns and Cities**



**Stuart Oag (Panel Facilitator)** SPF Vice Chair & Finance Director, Drum Property Group

Stuart is the Finance Director of Drum Property Group. After qualifying as a Chartered Accountant with KPMG, Stuart has 25 years' experience in the financing and delivery of complex land assembly, development and investment projects for blue-chip national and international occupiers. Specifically relevant to the panel discussion, Stuart has been involved with the delivery of 1200 homes in Scotland, with 900 of those being for UK institutional investment in the Private Rented Sector. In addition, Drum continues to grow its private residential portfolio across all the major conurbations of Scotland and remains one of the largest private landlords in the country.



Cllr. John Alexander Leader of Dundee City Council

Councillor John Alexander has held the position of Leader of Dundee City Council continuously since 2017, when he was elected as the youngest council leader in Scotland.

He has been an elected representative in Dundee since 2012, holding senior positions in the governing administration including, Convener of Housing and Convener of Neighbourhood Services.

His current role ensures that he has direct oversight and leadership of Dundee's £1 billion Waterfront Regeneration, the development of the Michelin-Scotland Innovation and the creation of the EDEN Project in Dundee, to name a few. With the city transforming itself into one renowned for being bold, ambitious and with a track record of delivery, Dundee's future remains bright.

Cllr Alexander also holds the role of Chairman of the Scottish Cities Alliance, an organisation which is a unique collaboration of Aberdeen, Dundee, Edinburgh, Glasgow, Inverness, Perth & Stirling in partnership with the Scottish Government. The Alliance is focussed on sustainability, economic development and promoting investment opportunities across the cities.
