Commercial Property Sales Update

<u>Summary</u>

- ➤ VALUE: The total value of commercial property sales in Scotland in 2019 hit £3.37bn. This is £136m (4%) higher than the total for 2018.
- NUMBER: The number of commercial property transactions (at all values) in 2019 was 4,667. This was the highest annual total in the decade.
- ➤ HIGH VALUE SALES: The number of £5m+ commercial property sales in Scotland stood at 97 and generated a combined value of £1.75bn.
- ➤ EDINBURGH: Edinburgh continued its lead of Scotland's largest cities with £1.01bn in commercial property sales during 2019, some £379m (60%) more than in 2018.
- ➤ GLASGOW: Glasgow also saw an increase in the total value of commercial property sales in 2019. Its total of £753m was £229m (44%) higher than in 2018.



Scottish Commercial Property Sales in 2019

- The total value of commercial property sales in Scotland grew in 2019 for the third consecutive year. At £3.37bn, sales increased by £136m (4%) in 2019 compared to the total for 2018 and is the highest annual total since 2015
- After 2014 and 2015, 2019 had the third highest total value of commercial property sales in the decade. The lowest annual total was in 2012, when there were just £1.5bn in sales.
- The number of commercial property transactions in Scotland (at all values) in 2019 was the highest in the decade, standing at 4,667.
- The number of commercial property sales in Scotland has increased every year since 2012. Between 2018 and 2019 there was an increase of 139 sales (3%).
- Within 2019, Q3 (July to September) saw the greatest combined value of commercial property sales in Scotland at £1.2bn. This figure was particularly high because of several high value transactions in Edinburgh. At £614m, Q2 had the lowest combined value of sales in 2019 and was the lowest quarterly total since 2014.







High Value Commercial Property Sales (£5m+)

- There were 97 high value (£5m+) sales of commercial properties in Scotland during 2019, which generated a combined value of £1.75bn.
- Sales at this section of the market accounted for over half (52%) of all Scottish commercial property sales by value.
- While the number of high value sales in 2019 was at its lowest level since 2013, the value generated for such sales in 2019 was £179m (11%) greater than the total for 2018 and the highest figure since 2015.
- In 2019, Edinburgh had the greatest number of high value commercial property sales, with 38 sales at or above £5m, generating combined sales of £731m.
- Glasgow had the second highest number of high value sales at 27, with a combined total sales value of £552m.
- In total, 15 of Scotland's 32 local authorities saw sales at this level of the market in 2019.

- Scotland's three largest cities Aberdeen, Edinburgh and Glasgow accounted for £1.97bn (58%) of the total value of commercial property sales in Scotland during 2019.
- **Edinburgh** maintained its lead of Scotland's cities with £1.01bn in commercial property sales during 2019, some £379m (60%) more than in 2018. In 2019, Edinburgh accounted for 30% of the Scottish commercial property market by value.
- Glasgow also saw an increase in the total value of commercial property sales in 2019. Its total of £753m was £229m (44%) higher than in 2018. By value, Glasgow had a 22% share of the Scottish commercial property market.
- Aberdeen was the only one of Scotland's three largest cities to see a year-on-year fall in commercial property sales. The city generated £207m in sales, £148m (42%) less than in 2018. Aberdeen accounted for 6% of the commercial property market by value in Scotland during 2019.
- While the total value of sales in Edinburgh was higher than both Glasgow and Aberdeen in 2019, its total was boosted by several high value transactions in Q3 (July-September). In both Q2 and Q4 Glasgow had greater sales (by value) than the capital.
